- Once payment has been processed, you will receive email confirmation along with a check-in process form. If no email address is provided, we will mail your confirmation and a check-in process form.
- All booth are 10'x10'. No full-sided canopies are allowed inside the buildings.
- WIFI is available
- Electricity is available for a limited number of booths - you may need to bring a long extension cord to access. Please request power ahead of time on rental sheet.
- One chair will be placed in each booth - you may request additional chairs at no additional cost.
- We are unable to allow crafters to set-up Friday night per school rules.
- Check in begins at 6:30 am on the morning of the market. Your booth must remain open until 2:00 pm.
- Vendor parking (after unloading) is to the South/East of the building in the student parking lot. >NOT in front of the school.<
