Dear Parents,

In compliance with the requirements of the Every Student Succeeds Act (ESSA) Jefferson Elementary School would like to inform you that you may request information about the professional qualifications of your student's teacher(s) or instructional paraprofessional(s).

### A. The following information may be requested for teacher(s):

- 1. Whether the teacher has met Washington teacher certification requirements for the grade level and subject areas in which the teacher provides instruction.
- 2. Whether the teacher is teaching under an emergency or other provisional status through which Washington qualifications or certification criteria have been waived.
- 3. The college major and any graduate certification or degree held by a teacher.
- 4. Whether the student is provided services by paraprofessionals, and if so, their qualifications.

### The following information may be requested for instructional paraprofessional(s):

Paraprofessionals must work under the supervision of a certified teacher. In schools that operate a schoolwide program, all paraprofessionals must meet professional qualifications. In a Targeted Assistance program, any paraprofessional who is working under the direct supervision of a certificated teacher must meet the professional qualifications.

Paraprofessionals can provide a copy of their high school diploma — transcripts are not necessary. In schools that operate a Title I, Part A program para professionals must have a high school diploma or GED and completed the following:

- 1. Completed at least two years of study at an institution of higher education; or
- 2. Obtained an associate's or higher degree; or
- 3. Pass the ETS Paraprofessional Assessment. The assessment measures skills, and content knowledge related to reading, writing and math;
- 4. Completed previous apprenticeship requirements and present a journey card or certificate. The portfolio and apprenticeships are no longer offered for enrollment; however, the Office of Superintendent of Public Instruction (OSPI) will continue to honor this pathway.

### To help engage and create our next generation of park visitors,

supporters and advocates, Federal Land Management agencies, launched the *Every Kid in a Park* initiative. The goal is to provide an opportunity for each and every 4th grade student across the country to experience their federal public lands and waters in person throughout the school year.

All 4<sup>th</sup> grade students at Jefferson were given an *Every Kid in a Park* pass that will all them and their families to visit any and all of the National Park Service parks for FREE from now until August 31, 2020. These passes are being given to 4<sup>th</sup> grade students though out the country in an effort to get kids out exploring all that the national park systems have to offer. ### **Five Hot Homework Tips for Parents**

Learning doesn't stop when the last bell rings at school. When students bring work home, it is a great time for parents to play a role in their child's education. Homework has many benefits, such as providing extra time for research or practice, helping students develop study skills and teaching time management skills. Here are five tips to help your child.

- Study space: Set up a quiet, well-lit area for your child to complete his or her homework. Try to remove any distractions from the surrounding area, like televisions, computers (unless used for the assignment) and loud conversations.
- 2. Imitation: Children imitate their parents. When your child is focusing on homework, join them in a similar, focused activity. Crack open a favorite novel while they complete their reading assignment, or balance your checkbook while they work through their multiplication tables.
- 3. **Time management:** Teach your child how to manage their time. Schedule events, homework, and tasks at home. For instance, after school, set a specific time as "homework time" and for tasks at home give them time limits.
- 4. **Encourage independence:** Some homework assignments are meant to be done by the student alone, and hovering can take away from the child's learning process. Try to step back, and if intervention is really needed, make sure to provide guidance, not just answers.
- 5. **Tackle a challenge:** Teach your child how to identify the difference between the "hard" homework questions and the "easy" ones. Have them set aside the easier questions for later and tackle the hard ones first.
